## Task 2.2 - Identifying gaps

- Task leader: ULA and CEPS
- Contributors: UTA, UPT, UTZ, UoM, AZUR, INCA, GNP, CCIT, CEFBIH, CEM, NASRI
- Aim:
  - Comparison between needs analysis (performed before the project) and the results of T2.1.
  - Identify gaps between sustainability action implemented in Western Europe and Balkans HEIs
  - Analyse reasons between these differences (legal, logistical, cultural, and economic).
