- 1) Establish Knowledge Hubs for Climate and Sustainability (KHCS) within each WBC HEIs
- 2) Mainstream climate and sustainability culture within WBC HEIs
- 3) Raise awareness of staff and student community on the needs for climate action within HEIs
- 4) Increase Synergies between academia, business sector and government
- 5) Reinforcement of networking and collaboration between staff and student communities of EU and WBC HEIs about climate and sustainability actions















- T3.1 Procurement, purchase and establishment of equipment and establishment of working space of the KHCSs
- Preparations for establishing the KHCSs in each WBC HEI: setting up the working space; KHCSs will be fully furnished for welcoming the staff engaged in the future management and activity of the Hubs; process of purchasing equipment guided by a review of planned purchases and by joint contribution (for specific purchases such as digital equipment and books) and HEIs own resources (for furniture and other infrastructural investment).









- Description of the Hub:
- It will serve as a working space for staff involved (working) in the Hub, and as "free" working space, dedicated to independent work of collaborators of the Hubs, external experts involved in the activities of the Hubs, and students (master or PhD). Several aspects have been taken into account when planning for this task:
- **1. Research and learning needs** (infrastructure for conduct practical and virtual activities that require both laboratory and field work; equipped with software that will be used for research; equipment will also be used for teaching and learning)
  - 2. Virtual mobility of people involved in the project (communication between project partners)
    - 3. Library establishment (library space)











- T3.2 Establishment of legal entity and foundation of KHCS
- Reviewing legal framework, governance systems of HEIs in order to establish the legal entity of the KHCSs. Based on the Statute of each WBC university, the process of foundation of institutes and research centers/hubs must follow an approval path. This requires drafting the proposal for establishment of the Hub, and with the foundation, the legal entity of the Hubs will be established. All WBC HEIs will actively report to the WP chair about the process. Advice and support from EU members, and guidance from NGOs.












- T3.3 Development of the 1Future Platform as a collaborative mechanisms between academia, business sector and government
- One joint virtual 1Future Platform will be developed to raise the interconnection between academia, business and government. Created by UTA and ULA and will be used by all partners in the consortium. It allows information and communication to flow freely among all stakeholders involved. It will serve as a mean for virtual communication between students and staff from one side and business sector on the other. Stimulating teamwork, allow participants to send and receive feedback (ideas, project, research proposals, case studies, etc.), used for teaching, learning and research. After making the commitment, each business will gain access to a personalized user profile so they can start making their processes more climate friendly.











- T3.4 Organizing workshops between HEIs, Business and government representatives
- These workshops will be conceived as multiplier events, for sharing the news on the establishment of KHCSs and 1Future platform and for gaining support from relevant stakeholders in participating in the platform. The main benefits of joint participation of all stakeholders in the platform will be explained and demonstrated during the workshop through simulated case studies.


