6	 Application for ISSN online: For print publication- 3 months before the release of first issue For online publication: after the release of 1 or 2 issues (both are in guidelines), issue contains at least 5 articles 		
	Note: Before proceeding for ISSN request (online publication), the URL (electronic address) of the publication is needed and the the name and address of the publisher must be		

displayed on the publication.
