Gap analysis between WBC and EU

- Identifying Gaps: clearly outlining the gaps observed between the EU and the Balkans in terms of climate and sustainability actions; categorizing these gaps;
- Analysis of the gaps exploring the underlying reasons for the identified gaps;
- Giving recommendations for future proposing actionable recommendations to bridge the gaps.







- Example of the interpretation
- Gap: Unlike the EU HEIs strategy, in WBC...
- Analysis of gap: In Bosnia and Herzegovina HEIs there is no sustainability strategy that describes...
- *Recommendation*: In WBC, the sustainability strategy needs to be separated from the development strategy because....







CONCLUSION – recap of the analysis should contain:

- Summarize the main findings of the analysis;
- Reiterate the importance of addressing the identified gaps;
- Emphasize the potential benefits of closing these gaps for the WBC HEIs.
