% of Climate Change and Sustainability Practices for each program type













% of Climate Change and Sustainability Practices for each program type















% of Climate Change and Sustainability Practices for each program type











■ Subjects offering Climate Change and Sustainability Practices ■ No of Subject








Services related to climate and sustainability at the University of Montenegro
