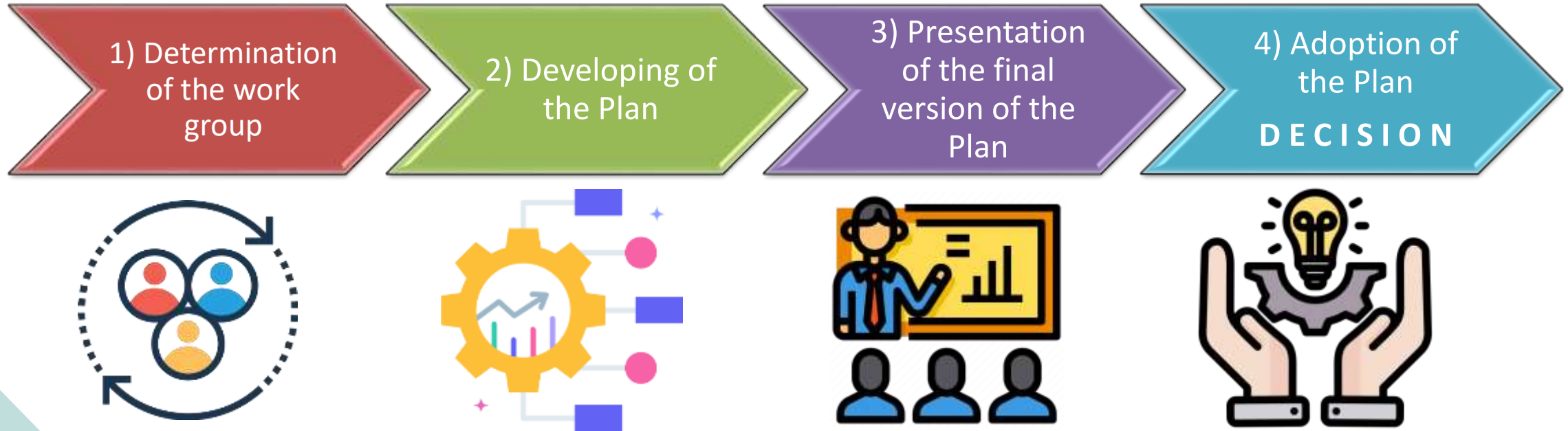

Process of adoption

- Administrative Board determines the work group for developing the plan
- The work group will consist with all relevant stakeholders:
 - Director
 - Heads of study programs
 - International relations office
 - QA office
 - Students
 - Administration
- The Administrative Board must approve and adopt the plan's final version.



Process of adoption



DECISION

- The Administrative Board makes a **DECISION** on the adoption of the final version of the Plan for Climate and Sustainability Action for CEPS
- Signed by the **President** of the Administrative Board

- 2.7 Food Health and Wellbeing

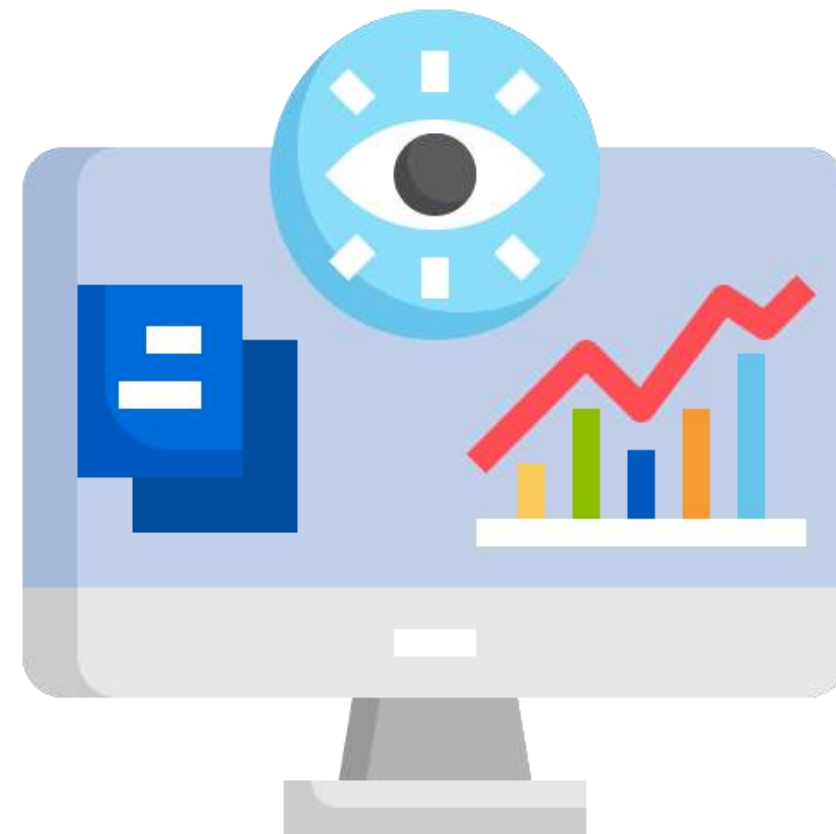


Plan Structure for CEPS

- **Third chapter**

- Monitoring and Reporting (Description of the methods and metrics that will be used to monitor progress; Establishment of reporting mechanisms)

- Determine KPIs for monitoring
- All staff members and students will be involved in implementation of the action plan
- Quality Assurance Manager is responsible for monitoring and reporting the action plan implementation.
- Once a year (December), he submits a report to the Director, the Board of Directors and the Senate
- **PROPOSAL:** The duration of the plan is 4 years

- **Fourth chapter**

- Action Plan for implementation

- Include goals, activities, outcomes, timelines, responsible parties, and required resources
- Action Plan for implementation
